You will present the dog for boarding in a clean and groomed condition and with up to date vaccinations, or titer test results.

You will need to supply the necessary dog food and treats for the duration of the stay. If additional food or treats are required you agree, upon presentation of a receipt, to refund Barnston Island Boarding.

You understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable and the unexpected may occur. You recognize that the benefits of an interactive playgroup are valuable to your dog, and accept the potential risks. You further agree to pay veterinary/medical expenses incurred as a result of injury to or caused by your dog.

You understand that Barnston Island Boarding will exercise all due diligence and care in the guardianship of your pet. You hereby waive and release Barnston Island Boarding, its employees, owners, and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including your own, and you expressly assume the risk of such damage or injury while your dog participates in or attends any function of Barnston Island Boarding, while on the grounds or the surrounding area thereto.

We are unable to accept bookings for a dog with aggression problems towards other dogs and/or people.

Reasonable efforts will be made to contact you in the event of an emergency. However, Barnston Island Boarding reserves the right to make decisions regarding your dog's health provided it is at all times acting in the best interests of the dog and on the advice of a veterinary surgeon. If your dog becomes unwell, has an accident and injures himself/herself or seems to be in any type of pain, we might need to take him/her to a veterinary surgeon. You agree to be responsible for payment of all the veterinarian fees incurred. You also agree not to hold Barnston Island Boarding liable for failure to seek veterinary attention or for decisions made under this contract.

You undertake to make full disclosure of any quality or characteristic which might make your dog not suitable for home boarding, including, but not limited to behavioural or health problems, anti-social behaviour including aggression, incontinence/lack of housetraining or excessive loud barking/whining. Failure on your part to disclose any matter which might render the dog unsuitable for home boarding will be deemed a material omission amounting to a fundamental breach of this agreement. You will also be liable for additional costs if Barnston Island Boarding experiences difficulties due to failure to disclose in the booking form any matter that would be accepted as reasonably unsuitable for home boarding.

A 50% deposit is due to confirm your booking. If Barnston Island Boarding has not received your deposit within 5 business days of receiving this form, your booking will be released.

Your deposit is not refundable if you cancel within 10 days of your booking.
